All contributions must be from personal funds and may not be reimbursed or paid by any other person. Contributions from corporations, national banks, federal government contractors and foreign nations are not permitted.

All contributions must be made from personal funds and may not be reimbursed or paid by any other person. PAC checks will be accepted.
